For FY 2016, RN BSN outcomes 6-10 were evaluated. Historically, in FY 2015 and 2014, due to changes in program evaluation plans, outcome 1-5 were evaluated. The last evaluation of RN BSN outcome 6-10 were in FY 2013, and evaluation was broken down into specific course outcomes at that time. In this document, results of FY 16 assessment will be compared to similar measurements in FY 13.

Outcome 6: Students will apply principles of health promotion, disease and injury prevention to maximize health outcomes.

Direct measurement using a rubric to evaluate this outcome indicates that 100% of students met this requirement. In FY 13, the last time this outcome was evaluated, the outcome was divided among course outcomes. For example, outcome 6.48 stated: Apply concepts of nursing leadership and management to promote principles of health promotion, disease and injury prevention to maximize health outcomes for individuals, families and communities. This outcome was measured upon completion of the management/leadership course. Results of the previous measurement, similar to FY16, were that both direct and indirect measures were achieved at the set benchmarks.

Outcome 7: Students will recognize the advocacy in regulatory, legislative, and public policy that influences the health care system.

This outcome was met based on the results of both direct and indirect measures. In FY 13, the last time this outcome was measured, outcome 7 was measured using course outcomes to include the following:

4600 #7 Recognize socioeconomic, political and global issues that impact nursing research agenda—benchmark met.

4800 #7 Identify concepts of nursing leadership and management for advocacy in financial and regulatory, legislative, and public policy changes that influence the health care system—benchmark met.

Trending data from both measures indicates this outcome is met and does not merit a change in the program. The next time this outcome will be measured will by FY 18.

Outcome 8: Students will collaborate with the client and health care team in providing compassionate and coordinated care.

This outcome was met based on the results of both direct and indirect measures. 100% of students rated themselves as satisfactorily meeting this program outcome. Additionally, 100% of students scored a minimum of 3 out of 4 on the collaboration portion of the grading rubric (benchmark 80%). In FY 13, this outcome was evaluated through individual course outcomes, for example:

NRS 4800 Utilize concepts of nursing leadership and management in collaboration with the client/designee and health care team in providing compassionate and coordinated care across the lifespan—this outcome was achieved for all 3 direct/indirect measures.

Trending data from FY 13 and FY 16 indicates no need for changes since the outcomes have been met. The next time this outcome will be measured will by FY 18.

Outcome 9: Students will demonstrate competent use of informatics to support clinical decision-making, mitigate errors, and improve outcomes.

This outcome was met based on the results of both direct and indirect measures. Eight out of nine (88%) of students rated themselves as satisfactorily meeting this outcome, while 100% of students scored a minimum of 3 out of 4 on the portfolio rubric for this outcome. In FY 13, the last time this outcome was measured, individual course outcomes were used, for example:

NRSG 4800 Incorporate informatics to support decision making, mitigate error, and improve outcomes in the nurse leader/manager role. Results indicated that this outcome was met above benchmark levels.

Trending data from FY 13 and FY 16 indicates no need for changes since the outcomes have been met. The next time this outcome will be measured will by FY 18.

Outcome 10: Students will synthesize concepts from liberal arts and sciences, clinical reasoning, and nursing to form the basis for professional practice.

In FY 16 100% of students met both direct and indirect measures for this outcome. The last time this outcome was evaluated was FY 13, when individual course outcomes were entered to Compliance Assist. For example:

NRSG 4600 Examine theories from nursing and related sciences as frameworks for nursing research.

Results from FY 16 and FY 13 indicate benchmarks are met for this outcome. This outcome will be re-evaluated in FY 18.
