New Business

- Curriculum updates-
 - BSN-First cohort (Fall 2018) started under new curriculum (54 students). Sarah and Jennifer are piloting a new evaluation in Exam Soft. The first NRSG Seminar will be held on October 1st at 6pm. See calendar for more information. We received a Gold grant to hold a white coat ceremony for the new BSN cohort which will occur immediately following the nursing seminar.
 - MSN-all MSN diplomas will now read MSN and subspecialty as there were problems with the PMHNP graduates sitting for certification. This will help with benchmarking as well.
 - DNP-new curriculum starts Fall 2018. Outcomes will remain the same. Some courses now have clinical hours or the hours were increased. Applied Stats has been added to the end of the program to assist with translational projects. 20 bridge and 13 new DNP students will begin Fall 2018. DNP Immersion will be held next week, see email from Paige with specifics.
- London Study Abroad-DNP students will participate in Spring 2019. Debby will send additional information.
- SON Assessment Report-See attached assessment report from Leslie. Explanation of BSN completion rates, as well as those for MSN and DNP completion. NCLEX pass rate for FY 18 was 100%. FNP certification pass rate was 100%. Faculty and program outcomes were discussed and approved (see assessment report).

- ANEW Grant update-28 students have accepted the ANEW grant (2 PMHNP, 26 FNP). In summer 2018, we were awarded an additional \$150K by HRSA to specifically focus on the opioid crisis. We will use a portion to bring two nationally known speakers to the 2019 Nursing Symposium, Barb Bancroft and Pete Early. Catherine will send links to the speaker's bios. All GC preceptors will have free admission. Will be held on Saturday, March 9th in Magnolia.

- Josie submitted for a \$1.5 million grant for sexual assault nurse examiner training (SANE). Will hear at the end of September if accepted.
- Writing Center Faculty Support (Joy Bracewell)- Overview of the writing center. Nursing has a big need for an online writing center due to online graduate programs. Students can book an appointment at the writing center through SSC in UNIFY.
- Sim Task Force Report-the NLN Jeffries theory has been adopted as our simulation model. We have joined INACL, SSH. Sterling is the chair of the task force as well as the Simulation Coordinator for Navicent Baldwin Sim Center. Will be looking at simulation design. Our goal is to become an accredited simulation center. Plan to standardize simulations.
