It is worth noting that the class consisted of five graduates, with three (60%) completing the surveys. This outcome is evaluated every two years, and because it is a new program and there were no 2015 graduates, comparison data is not available. This outcome will be measured again in FY 2019 and comparisons will be made between the outcomes.
- 2. Outcome 2 measures student ability to improve healthcare outcomes using scholarly inquiry and analysis of evidence. This outcome was achieved with both direct and indirect measures. The percent of students rating themselves as achieving this outcome at fully met or higher was 100%, the benchmark was set at 80%.
